Chief Appraiser, Marcel Pierel reported to the Board a certified estimate of the Appraiser Roll was sent to the comptroller on the 25<sup>th</sup> of July and a certified roll was sent to the comptroller on July 28<sup>th</sup> mailed to the entities on August 4<sup>th</sup>, 2023.

In addition, Mr. Pierel reported several changes with the passing of SB2 in November. The district board of directors will have five appointed members, three elected members and the tax-assessor collector. The cost for the general election of the three elected members will be an expense of the appraisal districts budget.

Also, the appointment of the Appraisal Review Board members will become the responsibility of the Board of Directors.

Other information was to inform the board 2023 is an election year for the board of directors. The process will begin in September.

The Just Appraised software that the board approved for the district is working well and deeds are almost up to date in the system.



The executive session was cancelled by consensus of the board.
