Motion by Mr. Sandars, a second by Ms. Robinson all in favor,


THAT, the Chief Appraiser's proposed budget for 2024 be accepted, as presented to the board.


FURTHER THAT, copies of the proposed 2024 budget be mailed to the taxing entities participating in the district by June 15, 2023.

Mr. Pierel reported the deed software "Just Appraised" has been up and running since May 31st and there will be a hands-on training in the next week. Mr. Pierel informed the board he will be traveling to Austin next week to attend the informal appeal by Perdue, Brandon, Fielder, Collins, and Mott attorneys to the comptroller for the Property Value Study on Angleton and Brazosport school districts. In addition, he reported the district received over 60,000 protests and out of those approximately 13,000 have been settled. Mr. Pierel also reported the ARB attorney, Peter Low will be coming to have a short training seminar with the Appraisal Review Board members this month. Mr. Pierel gave to the board a complaint letter from Mr. Bob Casale.

The closed executive session was cancelled by consensus of the board.
