THAT, pursuant to Texas Property Tax Code, Chapter 6, Subchapter A. Section 6:06 (f), the resolution authorizing check signatories be and is hereby adopted and that the resolution be attached to and made a part of these minutes.

Chief Appraiser, Marcel Pierel presented a plaque to retiring employee Preston Brown thanking him for his 42 years of dedicated service to the Appraisal District. Mr. Pierel also reported to the Board a certified appraisal roll was sent to the comptroller on July 19th and mailed to the entities on July 25th, 2024.

In addition, Mr. Pierel reported during the last Legislative Session a change was made to the Truth in Taxation postcards. The information now must be posted on CAD websites instead of sending postcards each year.

BCAD has received approximately 52 lawsuits and 200 arbitrations so far this year. Also, approximately 300 Disaster Exemption Applications have been received due to damages from Hurricane Beryl.

Mr. Pierel also reported he and Ms. Bulanek attended and spoke at the Hispanic Chamber of Commerce meeting and Mr. Pierel attended a TAAD (Texas Association of Appraisal Districts) meeting in Austin.

The board adjourned into Executive Session at 11:00 a.m. and reconvened into Open Session at 12:02 p.m.


THAT, the approval of a contract for the Chief Appraiser be tabled until the September 10th meeting.
